Overview


3E's family of Transportation services provides customers with a dependable resource for hazardous material transportation management needs. Customers can access transportation services on an as-needed basis or have their list of products pre-classified for transportation requirements. 3E can also provide real time access to up-to-date transportation regulations online or through a direct data feed.

Regulatory agencies such as the U.S. Department of Transportation (DOT) require that all hazardous materials or dangerous goods for transport be

appropriately classified, packaged, marked, labeled, placarded and shipped with proper documentation. Failing to comply can result in civil penalties and fines of up to \$50,000 per incident, per day. 3E can classify materials for any mode of transportation (ground, air or water) based on 49 CFR HMR, IATA, IMDG and Canadian TDG guidelines.

3E continually monitors changes in regulations, as well as manufacturer product data, and can update classifications on an on-going basis, reducing the time required by internal EH&S staff to keep track of such changes.

A number of services are available to choose from and can be delivered on a variety of platforms, including 3E Online®, a web-based subscription service; 3E OnCall, through the 3E EH&S Mission Control Call Center; and 3E OnData, delivering data through direct integration with a customer's existing ERP, EH&S, EMIS or other corporate system.



Products & Services

3E Transportation Hotline

3E's toll free Transportation Hotline service provides 24-7-365 access to live specialists at the 3E EH&S Mission Control Center, who respond with guidance on classification information, packaging, marking and labeling as well as regulatory questions for any mode of transport including ground, air and water. 3E specialists can advise whether or not a specific product in a specific quantity and type of packaging can be transported in compliance with regulations. 3E transportation specialists can also prepare and provide required shipping papers and documentation for any mode of transportation on behalf of a customer.

3E Transportation Classification

Based on a customer's list of hazardous materials, 3E can pre-classify the items based on the MSDS and/or the packaging for determination of regulatory requirements. The Online version provides reports by mode, such as main hazard class and regulated versus non-regulated. It

also provides the ability to view classification data by product, view required labels for product shipments, and print markings. The OnData version provides a data feed of classification information directly into a customer's corporate system, enabling the customer to reduce data management costs by providing a centralized repository for classification data to be shared with their entire enterprise.


3E Transportation Emergency Response

Companies that ship products containing hazardous chemicals can use 3E's 24-7-365 emergency response telephone number on shipping documents, MSDS or other documents to ensure compliance with transportation and emergency response requirements. 3E specialists can provide guidance on medical or health risks, mixing and reactivity hazards, PPE, spill cleanup procedures and product disposal, including assessing release reporting requirements and performing verbal customer and agency notifications. When a chemical release results in an

emergency situation, 3E can provide total incident management by dispatching a pre-screened emergency response contractor to the incident scene while providing immediate MSDS and chemical information to assist those handling the incident.

Ariel™ Transportation Data

Ariel Regulatory Content related to the transportation of dangerous goods encompasses regulations from around the world, spanning multiple modes of transportation, jurisdictional boundaries and language requirements. Ariel transportation content is available as a module through Ariel WebInsight™, a web-based global chemical regulatory compliance tool, which enables searching by UN or ID number, CAS RN, or Proper Shipping Name. Ariel Dangerous Goods data can also be added as a module to Ariel Data Manager (ADM)™ -EHSAP, for easy integration into SAP® EH&S. ADM is a custom interface for compiling, verifying and loading regulatory data.

Other professional staff are certified as Diplomats of the American Board of Toxicology, Specialists in Poison Information, and Veterinary Technicians.


