We maintain an online environment for suppliers to upload, enter and extract the data and documentation required. Suppliers can in turn communicate changes in formulations as well as revise material information.

3ESC's knowledge base offers a single, centralized repository to maintain your supply chain documentation. Data is organized by topic and indexed to enable users to search, assess and run reports by supplier, product or material. Data and documentation can also be integrated into your enterprise resource planning (ERP) system via 3E's data integration services.

VALIDATE TO IMPROVE ACCURACY

Are you sure the information you're passing to customers is accurate and up-to-date? 3ESC goes beyond data obtainment to provide validation of your supply chain intelligence. The data in this repository is vetted, analyzed against regulatory requirements, monitored and tracked against evolving obligations and measured to meet industry and customer expectations.

3ESC systematically assesses supplier response and determines a risk status for every material, supplier and product in the system, evaluating key factors such as:

- Whether a supplier responded
- Whether the response is current
- Conformance with compliance requirements
- Quality and consistency of data

Users can manage compliance risk for their manufactured products by creating relationships to their suppliers and raw materials through a bill of materials (BOM) feature. Once validated, the material compliance information can be aggregated and rolled up at a product level.

FACILITATE SUPPLY CHAIN COMMUNICATION

3ESC significantly reduces the risk of passing along incorrect or incomplete data to customers or further downstream. When a request for information comes in you'll have a robust and trustworthy source of information to leverage. For example, when a customer asks whether your product contains REACH Substances of Very High Concern (SVHC) and at what threshold, you can search the knowledge base at a material level and extract key information to use in the creation of product level documentation such as a REACH Article 33 certification.

For Conflict Minerals requests, 3ESC's Conflict Minerals Reporting Template (CMRT) generator feature enables users to quickly and easily create, store and manage company or product level CMRTs from information collected from suppliers and export it into the current industry standard Conflict-Free Sourcing Initiative (CFSI) format. Users can compose company and division level reporting profiles, roll up conflict minerals data for user defined groups of materials and create their own compliant CMRTs.

CONFLICT MINERALS

3ESC provides tools to assess the presence, origin and use of tin, tantalum, tungsten and gold (3TG) at both the supplier level and the product level to help you satisfy the obligations set forth by the Dodd Frank Wall Street Reform Act, Section 1502. 3E collects and manages CMRTs, obtaining information such as smelter data from suppliers and indexing it in the 3ESC platform, providing tools to analyze the data for completeness and accuracy and enabling you to aggregate information to complete SEC filings and/or create new CMRTs.

INGREDIENT DISCLOSURE

3ESC collects, validates and manages product ingredient composition data including Chemical Abstract Service (CAS) numbers, chemical names and concentration percentages.

REACH

3ESC collects, validates and manages compliance documentation regarding EU REACH requirements and declarations of SVHCs required by Article 33.

RoHS

3ESC collects, validates and manages RoHS certificates of compliance including whether products contain RoHS Article 4(1) restricted substances.

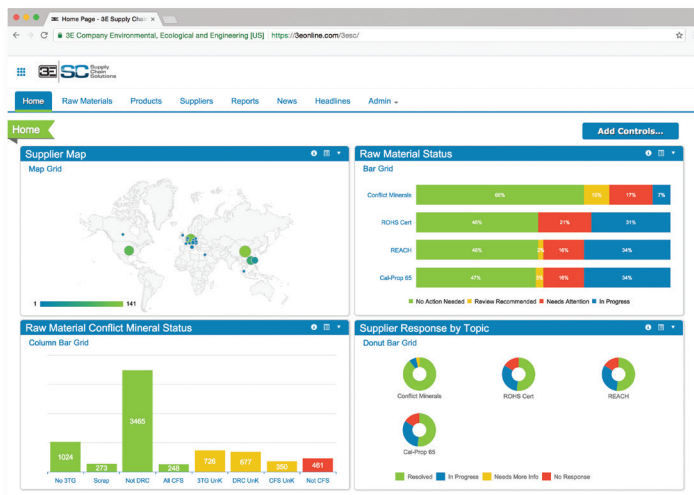
